

Business Activities:

1) IRON ORE EXPORT FROM INDIA:

We procure iron ore from kalne mines located at Redi port, sindhudurg, Maharashtra State. We are having our own machinery for extract the Iron Ore & prepare the quality as per our customer requirement regularly export Iron Ore to China since last 18 years. Iron ore has a great demand in international market and to meet requirements of our neighbouring country we are exporting iron ore to china procured from Kalne mines.

2) STEEL TRADING

We are in field of steel trading, we purchase the material from JSW, Tata & Arcelormittal. After procure the material, we sale the same in the local market from our Depot located at Kalamboli, Taloja, wada. Steel is a primary material for infrastructure, automobile, household & office hold furniture as well as gas pipe line.

2) ERW HR STEEL PIPE MANUFACTURING PLANT, SABARKATHA, GUJARAT-

In April 2019, the Board of the Company decided to expand its business by entering into manufacturing sector. For this, the Company acquired the business of the Partnership Firm namely, M/s Alaknanda Tubes having its factory located at Survey No. 36, Nava vas Village, Dist. Sabarkantha, Gujarat – 383215 which was in the production of ERW Pipes, with all its assets and liabilities, on a slump sale basis and as a going concern.



We have started manufacturing activity. We are manufacturing ERW HR steel pipe at Talod, sabarkatha, Gujarat. Capacity of the plant is 700 MT per month, now our target is to increase the production 1500 MT per month & the product will be manufactures as per BIS standard with standard marking. We have our own brand namely "virat Roofing & Pipe.

We have started manufacturing for profile at sabarkatha, Gujarat. There is huge demand for pipe & profile in the market. We are using standard raw material, which is purchased from TATA steel. We have a good business relation with TATA steel and keeping in mind this relationship, we are planning to execute business venture with TATA steel for pipe ERW products. In market there is huge demand for TATA product & it is not easily available. So our target is to fulfil market demand and take advantage of big business opportunity.
